Lawsuit Settled! TYC Pepper Spray Policy Rescinded!

Two pieces of news, I just confirmed with Advocacy Inc. attorney Richard LaVallo.

First, as predicted (not to brag, but [I called it](#) a "slam dunk"), the Texas Youth Commission has settled (read: lost) the lawsuit by Advocacy Inc. and Texas Appleseed and rescinded the Aug. 2nd directive allowing more prolific use of pepper spray. I've uploaded a [copy of the agreed judgment](#).

The prior TYC policy has been reinstated until the agency can go through a formal rule making process to legally change the administrative code.

LaVallo said Advocacy and Appleseed would like to assist the agency with drafting rules that are compliant with the Morales v. Turman settlement, which originally required the current, more restrictive language. At a minimum Advocacy will submit comments encouraging them to follow the Blue Ribbon Report's recommendations on pepper spray. If the agency doesn't create a policy that complies with Morales v. Turman, he said, they'll make a decision about whether to head back to court.

In other legal news, LaVallo said there's a hearing October 25 for a client of his who TYC wants to transfer directly to TDCJ. He said the case will ask a court to resolve whether TYC should follow SB 103 and [its own rules for 19-20 year olds](#), or make a different decision based on "public safety." LaVallo knew of other individual cases, too, that were likely to head to court on the topic, he said, and expected a case of first impression to crop up soon.

Having predicted TYC court losses on both these issues (one down, one to

go), I'll make a further prediction: TYC will see quite a few more legal losses before it sees many victories. First in juvie criminal courts, then in civil litigation. Their leaders have embarked on a legally troublesome path, [ignoring expert advice](#) to model their policies based on their [experience in adult corrections](#).

In the wake of today's setback, the agency has an opportunity to learn some important lessons. Administrators should make claims of "transparency" actually mean something, and work with their critics instead of forcing them into court. Pushback from trying to ram through new use of force policies outside the legal process should teach agency leaders they have to play by the rules. If they would, they'd start to save themselves a lot of trouble.

In addition, ask how many staff injuries occurred during that same time period? Then ask the hot question. How much money has this state paid for workers compensation claims and injuries to kids as a result of youth aggression? How much did this state pay out for overtime as a result of staff shortages due to workers injuries associated with physical restraints? That number will shock you. But then, let's compare that figure to the post Aug. 02 memorandum. Now let's talk.

For the sake of those young offenders and corrections officers, revise the policy first thing Monday morning and post it on the register. Let the people banter. But for the record, the kids chilled when the hot stuff came out, making it much more easy to reason with them and keep them from screwing up more. In the mean time, while we are reverting back to old policy and the young men are getting violent again, expect them to stay longer, or even worse, get arrested and charged as adults. I don't know offhand the stats, but lets say for the sake of argument OC worked so well injuries reduced to 1/3 the June rate. That would still be higher than the injury rate 5 years ago, when OC spray wasn't used. OC is a quick fix that creates its own set of concerns, and masks underlying problems that will blow up sooner or later down the line

I agree 100% with this statement. But wouldn't you agree you have to have staff to do anything else constructive? I mean, some of these facilities are operating at 40% of their budgeted FTE's and two primary reasons are staff out due to injuries as a result of youth aggression and quit frankly, no one wants to be employed where violence is so widespread. I agree that pepper spray is not in the best interest of anyone in the future, but man we are in a crisis now and we have to (1) keep these JCO's coming to work to keep the institutions safe and stop hurting kids in these physical restraints, and (2) stabilize the culture by means of stopping the violence. And I agree, we need a treatment program.

BTW, we have been using pepper spray since 1995, and under the current policy as it is now (physical restraint before pepper spray), workers compensation claims rose about every year. We are talking many, many

I work on a 6 acre facility and 2100 cameras will be installed there camera price alone comes to \$840,000 dollars not including hardware. I worked at the Nevada test site and we did not have that many cameras. Total price for our facility at the present time is 1.3 million dollars for the first phase. And there is a phase 2 to be done on all outside buildings. Each new radio cost is \$4,000 apiece. If you bought 100 radios for each facility the total cost would be around \$5,850,000 dollars. And yes I have been to Evins to many times in the last few years dealing with the problems. When family members are able to show up on your door steps and tell you to leave there youth alone, the problem lies with the fact that the youth are to close to there home. Not to mention that almost every youth there is from the valley.

Who said our population was down? Remember, we closed two institutions. Most of the units, except Ron Jackson, are overcrowded right now. Mart II is way over. Crockett has had to open a dorm that had previously been closed because it was not suitable for housing youth. Intimidation of youth and line staff is way down, compared to where it was when Chester was running the institutions. However, and this is the really sad part, Linda Reyes had already gotten rid of Chester and was leading an orderly turn-around of the agency. Remember, she moved over from Rehab Services to Deputy Exec. just as the WTSS scandal was breaking. She had been fighting Chester for years, so she had to establish her case for his removal. That took time, because Dwight trusted Chester, who was busy stabbing Dwight in the back every chance he got.

Don't even mention Steve Robinson - he was the one who got us into the mess in the first place. Chester Clay was his protege.

There are a lot of folks around who came on after Chester was in control who are wanting him back. What they are seeing is the rebound effect on the part of the youths after years of control by intimidation. Intimidation only begets surface compliance. Now that the intimidation of the youths has been removed, there is a vacuum, and the kids are taking advantage of it. It will take a long time to get back to control through establishing trusting relationships. I'm not talking about being soft on these kids - I'm talking about establishing limits through firm, fair and consistent application of reasonable discipline.
